



PUBLIC FINANCE AND PUBLIC DEBT REPORT, JULY 2010

The public finance and public debt preliminary results as of July 2010 were released today.

The main results during the January-July period are the following:

- The Public Sector deficit was Ps. 151.6 billion and Ps. 19.4 billion excluding **PEMEX's investment, results consistent with the approved public deficit for the year.**
- Budgetary revenues were higher by 1.0 percent in real annual terms. This moderate growth is due to the revenues from the remnant of operation of Banco de Mexico by Ps. 95.0 billion which were received in April 2009, when adjusting for this budgetary revenues show an increase of 7.6 percent in real annual terms.
- Non-oil tax revenues, oil revenues and revenues of public entities under direct budgetary control other than PEMEX increased by 12.0, 4.4 and 3.6 percent in real annual terms, respectively.
- Net expenditures were higher by 0.9 percent in real annual terms. Within programmable expenditures, worth highlighting are the resources channeled to health, social security, education, social assistance, potable water and sewerage.
- Shared revenues increased by 17.3 percent in real annual terms.
- **The Federal Public Sector's** net domestic debt increased by Ps. 144.9 billion and the **Federal Public Sector's** net external debt increased by US\$ 5.9 billion with respect to the end of 2009.

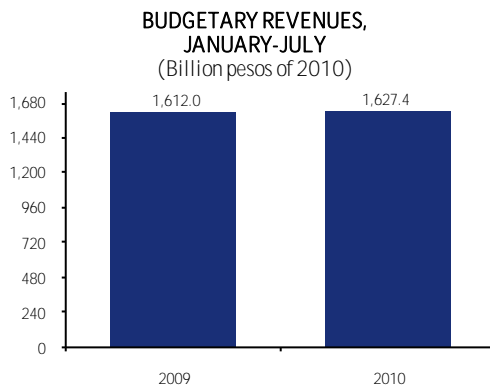
Evolution of the Public Finances during January-July

As of July 2010, the Public Sector's balance posted a deficit of Ps. 151.6 billion. The primary balance posted a Ps. 7.2 billion deficit. **If PEMEX's investment is excluded**, the public sector's balance would register a deficit of Ps. 19.4 billion. These results are consistent with the approved deficit for 2010, in compliance with Article 17 of the Federal Budget and Fiscal Responsibility Law.

Public Sector Budgetary Revenues during January-July

The Public Sector's budgetary revenues were Ps. 1,627.4 billion, amount 1.0 percent higher in real terms than the one registered during the same period of the previous year. The moderate growth in the period is due to the revenues registered in April 2009 by Ps. 95.0 billion associated with the remnant of operation of Banco de Mexico. A real annual increase of 7.6 percent is observed when excluding this remnant of operation from the

comparison base in 2009. The evolution of the main components of budgetary revenues was the following:



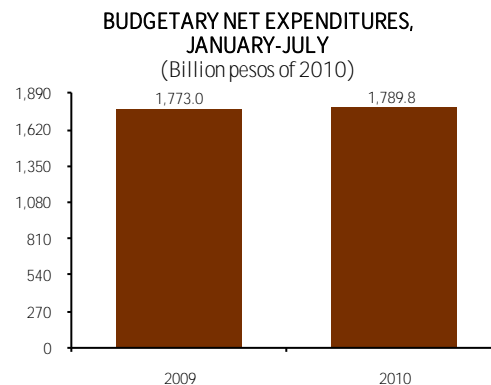
- Non-oil tax revenues were Ps. 785.4 billion, amount 12.0 percent higher in real terms than that observed during the January-July period of the previous year. Excise tax collection, VAT and Income tax collection (which includes the IETU and the Tax on Cash Deposits) increased by 27.7, 19.6 and 8.9 percent in real terms, respectively.
- Oil related revenues (which include **PEMEX's own revenues, royalties and fees**, excise tax collection on gasoline and diesel, and the tax on oil returns) totaled Ps. 516.6 billion, amount that is 4.4 percent higher in real terms than the one registered in the same period of 2009. This result is explained mainly by the higher price of the Mexican oil mix (71.0 dpb compared with 45.5 dpb observed in the same period of last year), that was partially offset by the real appreciation of the exchange rate by 11.7 percent with respect to the same period of the previous year, the higher value of imports of hydrocarbons by 49.4 percent in real terms and the decline in the oil production platform of 1.8 percent.
- Revenues of public entities under direct budgetary control other than PEMEX were

Ps. 255.3 billion, which represented an increase of 3.6 percent in real terms with respect to those registered in the same period of the previous year. This is mainly explained by the higher value of energy sales and higher fees and social security contributions.

- Non-tax non-oil revenues totaled Ps. 70.1 billion, amount lower by 58.8 percent in real terms with respect to the same period of the previous year, due mainly to the fact that in April 2009 non-recurrent revenues by Ps 95.0 billion were received associated with the remnant of operation of Banco de Mexico.

Net Budgetary Public Sector Expenditures during January-July

During the first seven months of the year, net budgetary expenditures of the Public Sector totaled Ps. 1,789.9 billion, amount higher by 0.9 percent in real terms to the one observed in the same period of 2009.



Paid programmable expenditures totaled Ps. 1,366.8 billion, amount 1.5 percent lower in real terms than the one observed in the same period of the previous year, due to the effort



to anticipate expenditures as part of the countercyclical measures adopted during 2009. Within this item, worth highlighting are the resources channeled to health, social security, education, social assistance, access to drinking water and sewerage.

Resources transferred to Federal Entities and Municipalities through shared revenues, decentralization agreements and reallocations increased by 5.4 percent in real terms. Shared revenues increased by 17.3 percent in real terms due to higher Federal shareable revenues, while the remainder of the resources distributed to Federal Entities and Municipalities decreased by 2.2 percent in real annual terms.

The Public Sector's financial cost was Ps. 143.6 billion, amount 11.4 percent lower in real terms than the one registered in the same period of last year. This is explained by a reduction in transfers to past support programs associated with the 1995 banking crisis, lower interest rates and the appreciation of the exchange rate.

Stock of Public Debt as of July

At the end of July, **the Federal Government's net domestic debt** was Ps. 2,630.4 billion, amount that is Ps. 159.1 billion higher than that observed at the end of 2009. The change in the stock is explained by net indebtedness of Ps. 249.2 billion, by upward adjustments to the inflation indexed debt by Ps. 15.2 billion and an increase **in the Federal Government's financial assets** by Ps. 105.3 billion.

The stock of the Federal Government's net external debt in July was US\$ 50.5 billion, amount US\$ 4.3 billion higher than the one observed at the end of 2009. This result is explained by a net indebtedness of US\$ 2.5 billion, by downward accounting adjustments by US\$ 0.3 billion and a decrease in financial assets in foreign currency by US\$ 2.0 billion.

The stock **of the Federal Public Sector's net domestic debt** (Federal Government, PEDBC's and development banks) at the end of July was Ps. 2,739.0 billion, which implies an increase of Ps. 144.9 billion with respect to the stock recorded at the end of 2009. This is due to net domestic indebtedness during the period of Ps. 251.6 billion, upward accounting adjustments by Ps. 16.4 billion and an increase in the non-financial **Public Sector's assets** by Ps. 123.1 billion.

The stock **of the Federal Public Sector's net external debt** was US\$ 97.6 billion, amount that is higher by US\$ 5.9 billion than the one registered at the end of 2009. This result is explained by a net external borrowing of US\$ 3.1 billion, downward accounting adjustments by US\$ 0.6 billion and a decrease in foreign financial assets by US\$ 3.4 billion.
